Advanced payment is required in order to reserve booth space. Booth placement is determined by postmark and electrical requirements. Non-profit groups such as service organizations and children's groups must provide a tax-exempt letter and will be charged \$20 per 10-foot space. **Non-profit groups will be placed in the best available booth space within five (5) days prior to the Street Fair.**
